Management of Double R Trading and RR Mobility entirely in the hands of Robert van de Nadort

- **Roelof Schiltmans transfers interest and 'retires'**

Gorinchem, 1 October 2015 – After having worked on the sales team of the well-known Motorhuis Safe, among other things, in 1995 Roelof Schiltmans founded Double R Trading together with Robert van de Nadort. The company was and is specialised in the import and export of motorcycles, quads and engine parts. Now the time has come for Schiltmans to enjoy a well-earned rest. Joint owner and board member Robert van de Nadort is to take over full responsibility for the day-to-day management of Double R Trading and its subsidiary, RR Mobility. Van de Nadort has worked in the motorcycle sector since 1988. His cooperation with Roelof Schiltmans began at Motorhuis Safe where he ran the Motor Trading Company.

Schiltmans says farewell

Roelof Schiltmans joined Motorhuis Safe as a salesman in 1976 and was appointed as commercial manager in 1988. In 1992 Motorhuis Safe was taken over by the Euro Motorcycle Group and Schiltmans joined the board of directors.

In 1995, Roelof Schiltmans decided to start his own company with Robert van de Nadort and Double R Trading bv was established in Leerdam, specialising in the import and export of motorcycles, quads and parts.

Business boomed and new premises became necessary. So in 2001, Double R Trading moved to a newly built site in Gorinchem which included three loading platforms. In the various warehouses, there is room to store motorcycles, quads and parts for virtually every make. The subsidiary RR Mobility bv was established in 2010 for the import and distribution of the innovative GOVECS electric scooters in the Benelux.
